Platinum Parking reserves the right to increase the Monthly Parking Charge in written notice to Obligor at least 15 days prior to the effective date of the increase. Either Parker or Obligor may cancel Parker's right to park in the Office Tower/Retail Garage effective as of the last day of the current calendar month by written notice delivered to Platinum Parking on or before the 15th of the current month. If notice is delivered after the 15th, Obligor will be responsible for the Monthly Parking Charge for the following month.

III: PARKING AGREEMENT AND RELEASE

PARKER RELEASES THE OWNER OF THE PROJECT ("OWNER") AND PLATINUM PARKING FROM, AND WILL INDEMNIFY AND HOLD OWNER AND PLATINUM PARKING HARMLESS AGAINST, ALL CLAIMS, LIABILITIES, DAMAGES AND COSTS ARISING OUT OF (i) INJURY OR DEATH OF PARKER OR ANY PASSENGER IN PARKER'S VEHICLE(S) RESULTING FROM A COLLISION OCCURING WITHIN THE BOUNDARIES OF THE PROJECT EITHER WITH ANOTHER VEHICLE OR WITH ANY STRUCTURE OR IMPROVEMENT LOCATED WITHIN THE PROJECT (ii) DAMAGE TO OR LOSS OF ANY PROPERTY BELONGING TO PARKER, OR ANY PASSENGER OF PARKER'S VEHICLE(S), INCLUDING WITHOUT LIMITATION THE VEHICLE(S) AND ANY ITEMS OF PERSONAL PROPERTY LEFT IN THE VEHICLE(S), OR (iii) INJURIES TO THIRD PARTIES OR OWNER OR DAMAGE TO THE PROPERTY OF THIRD PARTIES OR OWNER CAUSED BY PARKER'S OPERATION OF A VEHICLE IN THE PROJECT.

Parker will comply with the rules and regulations promulgated by Platinum Parking and/or Owner for the Office Tower/Retail Garage and park only in areas designated by Platinum Parking.
